

Edge Acrobatic Gymnastics

Terms and Conditions

We require you to fill in a google membership form with all the gymnast's correct information, this will enable us to keep your child safe.

Edge Acrobatic Gymnastics members are required to pay an annual club membership fee which is paid when joining and is renewed every January. Edge Acro membership covers the administration that must be carried out to make sure the club runs smoothly, and everyone can take part. This including day to day running of the club, dealing with finances, class logistics, correspondence etc.

British Gymnastics Insurance

Every gymnast is required to hold British Gymnastics Insurance to participate in Edge Acrobatic sessions. The insurance is an annual payment that is renewed every September. British Gymnastics insurance covers a gymnast for 1 taster session, after this, the gymnast is required to become a fully paid British Gymnastics member, prior to your child's first class. The insurance is an annual fee paid directly to British Gymnastics themselves and it is the Parent/Guardian's responsibility to set up their child's insurance directly with British Gymnastics.

Those who do not hold a valid BG membership, will not be able to attend training sessions. (Please, note that the terms and the fees of the BG membership and Personal Accident insurance are fully regulated by our governing body – British Gymnastics, rather than by Edge Acrobatic Gymnastics. For more information, please check the British Gymnastics membership policies).

Fees

All fees must be paid in full. Edge Acrobatic Gymnastics reserves the right to refuse entry or sit your child out of class until the payment is cleared.

Edge Acrobatic Gymnastics will not refund or credit any fees if you choose to stop. Edge Acrobatic Gymnastics do not authorise any refunds, make-up sessions or additional classes if your son/daughter is absent.

All payments must be received by the date given to guarantee their space. This is first come first serve.

If a gymnast joins the club after the start of term, proportional payment for the remainder of the term will be applied.

In the event that a class needs to be cancelled due to unforeseen circumstances, Edge Acrobatic Gymnastics will try to provide a replacement class. In such a situation, no alternative financial refund is available.

Gymnastics is a sport, which requires commitment and Edge Acrobatic Gymnastics strongly recommends full attendance.

Parents/carers are not allowed in the hall during general training sessions unless invited inside by a lead coach or in an event of and an emergency. No unauthorised personal will be allowed in the training area. However, please note that there is a parent/guardian watching week for adults every term, where you can view your child's class to see their progress.

Safety

While in the gym all aspects of safety will be taken into precaution by all staff. It is the parents/guardian's responsibility to follow the safety aspects outside of the gym and the surrounding areas inside and outside the building.

Edge Acrobatic Gymnastics do not accept responsibility or liability for lost/stolen items within our venues, so please do not allow children to bring in any valuables to sessions. Any lost property we find will be picked up at the end of the session and kept for 2 weeks.

Gymnastics is a sport, which requires a high level of safety and discipline. Therefore, coaches can use appropriate level of verbal discipline if they deem necessary to avoid accidents and minimize injuries.

Coaches remain the right to sit a gymnast out of class if he/she does not follow the club's rules and safety regulations.

Please drop off & collect your child promptly from their gymnastics class/training session. Children are prohibited from leaving the session unaccompanied, unless they are over the age of 8 and Edge Acrobatic Gymnastics have received written permission from a parent/guardian.

Gymnasts with any medical requirements must inform their coaches of the requirements. The medication must be in a sealed, named bag where it can be easily accessible. The gymnasts will bring the bag into the gym with them and it is to be given to the lead coach.
